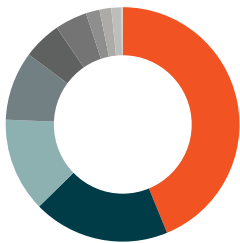

Solactive Global Uranium & Nuclear Components Total Return Index

This particularly includes uranium mining, exploration, uranium investments and technologies related to the uranium industry. The Index will include a minimum of 20 components at every rebalancing.
