Investment approach

- Seeks to track the performance of the MSCI US Investable Market Utilities 25/50 Index.
- Multicapitalization equity in the utilities sector.
- The fund employs a passively managed, full-replication strategy when possible.
- If regulatory constraints prevent full replication, the fund uses a sampling strategy to approximate the index's key characteristics.
- The fund remains fully invested.
- Low expenses minimize net tracking error.

About the benchmark

- The MSCI US Investable Market Utilities 25/50 Index includes stocks of U.S. companies within the utilities sector.
- The sector is made up of electric, gas, and water utility companies as well as companies that operate as independent producers and/or distributors of power.
- Uses GICS methodology and clearly classified sectors.
- Offers broad representation of the target sector across large-, medium-, and small-cap companies.

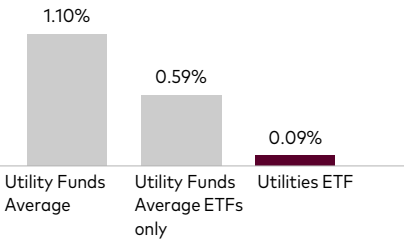
